A Substitute Teacher must...

- Have strong oral and written communication skills and basic computer skills

- Undergo a required criminal history background check
- Possess **one** of the following:
 1. Substitute Teacher Certification (60 college credits; Program for Parents will assist in certification process if needed)
 2. Child Development Associate (CDA) Certificate
 3. Certified Child Care Professional (CCP) Certificate
 4. Associates Degree in Early Childhood Education or Child Development
 5. Six college credits in Early Childhood Education or Child Development **and** nine college credits in Education, Psychology, Health Care, Nursing or any field related to child growth or development
 6. Early Childhood Experience within a licensed center (2 years minimum)
